Children's Advocacy Centers of Illinois Unveils New Statewide Awareness Billboard Campaign

SPRINGFIELD, IL. Established in 1995, The Children's Advocacy Centers of Illinois (CACI) is the network that coordinates and provides a comprehensive response to child abuse in Illinois. As the leading resource on child abuse issues, we stay abreast of the latest research and literature within the field, as well as the most child-friendly approaches in investigations and treatment.

CACI is dedicated to the development and growth of the 40 Children's Advocacy Centers (CACs) throughout the state. CACs provide forensic interviewing, advocacy and medical/health therapeutic referral services to children and non-offending family members involved in cases of child sexual abuse, severe physical abuse and child fatalities.

In FY19, 14,291 children walked through the door of an Illinois CAC where their voices were heard. On Monday, August 26, a new statewide billboard campaign will be launched. The "Children Start To Heal The Moment They Are Heard" campaign is aimed at child abuse response and prevention. We understand that effective advocacy requires both information and action, therefore 14 billboards (locations attached) are being placed throughout Illinois. The billboard campaign includes the CACI website: www.childrensadvocacycentersofillinois.org that provides comprehensive information regarding contact information for local CACs, signs of abuse, Illinois statistics, training opportunities and more.

In Illinois, our vision is simple: to ensure every child in the state of Illinois has access to the services offered through a CAC. While we cannot stop abuse, we can make a significant impact through prevention education and multidisciplinary services provided to the children who have suffered the horrors of abuse. We work together in a unified voice on behalf of Illinois' children.


