

VICTIMS' DEMOGRAPHICS


Victims' Sex



Victims' Race




Victims' Age



PERPETRATORS' DEMOGRAPHICS


Perpetrators' Sex


Overview of FY22 Annual Needs Assessment

A. GOAL STATEMENT: CACI is committed to partnering with its member centers, lawmakers, and other stakeholders to advocate for legislation to positively impact CACs, the multidisciplinary team model, and the overall health and well-being of Illinois' children.

B. GOAL STATEMENT: CACI is committed to advocating for and administration of state and federal funding for eligible member CACs in a manner that (1) Supports comprehensive statewide CAC coverage; and (2) Protects and promotes the integrity of the CAC model, the diversity of CACs throughout Illinois, and the consistent delivery of the full array of evidence-based services



PRIORITY FOCUS AREA IV: CAC DEVELOPMENT & MEMBERSHIP SERVICES

A. GOAL STATEMENT: CACI is committed to ensuring that children and families throughout Illinois have consistent, equitable, and timely access to the full array of CAC services as outlined within the NCA Accreditation Standards.

B. GOAL STATEMENT: CACI is committed to ensuring its member Centers, and those communities working to establish MDTs or CACs, have access to relevant, timely, and affordable evidence-based training, technical assistance, and networking for CAC Staff, Multidisciplinary Team, and Board members.



Outcome Measurement System (OMS)

The OMS program gives families and multidisciplinary team (MDT) members a voice in the CAC process by gathering feedback on satisfaction with procedures, as well as short-term and longer-term outcomes of the CAC/MDT model. Effective collection practices allow CACs to provide this opportunity broadly and efficiently, increasing the scope of the feedback to then use for program improvement purposes.




